

**TERMS & CONDITIONS**
**IAVM ALLIED GROUP MEMBERSHIP**

**Allied Group Membership** delivers an affordable discount pricing structure which enables a firm or organization engaged in providing product, equipment, services or attractions to public venues.

*2 OPTIONS TO CHOOSE FROM:*

**Tier 1:** Add up to 5 employees. Each current and new employee's renewal date will be the same. Current members will retain their original join date.

**Dues: \$2,000 USD**

**ADDITIONAL MEMBER PERKS:**

- Career Center – 2 free job posts annually, save \$250 each
- FM Magazine – 2 print copies per membership
- Advertising – 10% off member rates
- Email blast - \$2,500, save \$500
- VenueDataSource Research Reports – 2 reports annually

**Tier 2:** Add up to 10 employees. Each current and new employee's renewal date will be the same. Current members will retain their original join date.

**Dues: \$4,000 USD**

**Tier 2 cont. - ADDITIONAL MEMBER PERKS:**

- 2 additional full conference registrations w/a single 10x10 booth purchase
- Career Center – 2 free job posts annually, save \$250 each
- FM Magazine – 3 print copies per membership
- Advertising – 10% off member rates
- Email blast - \$2,500, save \$500
- VenueDataSource Research Reports – 2 reports annually

One individual shall be designated as the Allied Primary Member/Representative (principal contact) for the group membership. Said individual will be responsible for renewing the membership annually and making roster updates for the membership. A firm or organization will select either Tier 1 or Tier 2 when applying and may sign up to five or ten direct employees as members.

Company name: A single name must be used in connection with all employees listed as Allied Group Members.

**DUES:**

Allied Group Membership – Tier 1 or Tier 2 – A single payment is required to establish and renew Allied Group Membership via check, credit card or wire. To pay by credit card, call Member Services at 972.906.7441.

Note: Wire payments require an additional fee of \$25. If paying by wire, transmit a total of \$2,025 USD or \$4,025 to join or renew in this category. Details are listed on the membership invoice.

If a PO is provided, membership will be activated upon receipt of dues.

Dues will not be prorated for existing members that have previously joined or renewed.

A firm or organization will pay applicable dues as outlined and will meet criteria established by the Board of Directors.

All individuals/members are voting members.

**FIRMS THAT DO NOT QUALIFY:**

- Public assembly venues – should apply as Professional Group Members

All individuals/members are expected to adhere to the principles outlined in IAVM's Code of Ethics.

**Transition:** Memberships are transferrable when an employee departs; if the new company does not participate in IAVM's Allied Group Membership program upon the employee's arrival, the departing member will be responsible for their membership dues. The initiation fee will be waived if the employee is the first or only member at the new company. The departing member will have 60 days to set up their individual membership with IAVM at the Allied Membership dues rate. If the new firm/employer is participating in Allied Group Membership and has space under the maximum number allowed, the principal contact may add the employee to their roster via IAVM's website by selecting the option "Update Allied Group Membership Profile".

If the Primary Member/Representative (principal contact) leaves the firm/organization, responsibility for the IAVM Allied Group Membership will be assigned to the next highest ranking member by IAVM unless otherwise notified. Note: We ask that companies be strategic about who is responsible for updating the roster. It may not be practical for the top executive to be listed as the primary member because of the number of updates that may be required to keep the roster up-to-date.

IAVM reserves the right to approve or deny any membership applications.
